

Adventures Day Nursery Full Fees from July 2024

Daily rate: £82

Full fees will be charged for 52 weeks per year. There are no reductions for bank holidays or nursery closures due to staff training. If your child does not attend for any reason including holidays and sickness full fees will be charged.

15 hours stretched

All children are entitled to the educational grant of 570 hours a year from the term after their 3rd birthday. This means that they will have their fees reduced by 11 hours a week for 51 weeks if they are on a stretched contract with Adventures. The government education grant does not cover all nursery costs including food and we therefore charge for these costs as an extra.

15 Hours term time offer

Your child will be entitled to 15 hours childcare per week over 38 weeks of the year according to the local authority term dates and at times agreed with the nursery.

The government education grant does not cover all nursery costs including food and we therefore charge for these costs as an extra of £2.68p per hour.

These extra charges will be charged for 38 weeks per year. There are no reductions for bank holidays or nursery closures due to staff training. If your child does not attend for any reason including holidays and sickness fees will be charged.

If your child attends agreed hours in excess of the 15 FREE hours they will be charged at £8.20 per hour.

30 Hours term time offer

If your family is entitled to 30 hours FEEE childcare per week and you would like this as a term time offer this will be over 38 weeks of the year according to the local authority term dates and at times agreed with the nursery.

The government grant does not cover all nursery costs including food and we therefore charge for these costs as an extra of £2.68p per hour.

These extra charges will be charged for 38 weeks per year. There are no reductions for bank holidays or nursery closures due to staff training. If your child does not attend for any reason including holidays and sickness fees will be charged.

If your child attends agreed hours in excess of the 30 FEEE hours they will be charged at £8.20 per hour.

2 year old working parent entitlement

Your family may be eligible for 15 hours funded childcare a year from the term after their 2nd birthday, this means that they will have their fees reduced by 11 hours a week for 51 weeks if they are on a stretched contract with Adventures.
